# **Privacy Policy**

Crafted&Co. ("we", "us", or "our") is committed to protecting your privacy and personal data. This information is collected using cookies and similar tracking technologies.

We may receive limited information from trusted third parties such as:

- Payment service providers
  - Delivery and logistics partners
  - Analytics providers
  - Marketing and advertising platforms

## 2. How We Use Your Information

We use your personal data for the following purposes:

- To process and fulfil orders, including payment processing and delivery

  - To send marketing communications (where you have given consent)

  - **Legitimate interests:** to operate, improve, and protect our business, provided your rights do not override these interests

## 4. Cookies and Tracking Technologies

# **Returns Policy**

At Crafted&Co., we specialise in **personalised and made-to-order items**, created uniquely for each customer. Because of the custom nature of our products, please read this Returns Policy carefully before placing an order. By completing a purchase with Crafted&Co., you confirm that all information provided is accurate and that you agree to the terms outlined below.

## **1. Personalised & Made-to-Order Items**

All Crafted&Co. products are **personalised** based on the information provided by the customer at checkout. This includes, but is not limited to:

- Names, initials, dates, or text
- Design selections
- Colours, styles, or custom options

It is **the customer's responsibility** to carefully review and verify **all details** before submitting an order.

**Orders cannot be changed, cancelled, or refunded once production has begun.**

Crafted&Co. is **not responsible for errors** resulting from incorrect or incomplete information provided by the customer, including spelling mistakes, formatting choices, or design selections.

## **2. General Returns Policy**

Due to the personalised nature of our products:

- **All sales are final**
- We do **not accept returns or exchanges** for change of mind, incorrect personalisation details, sizing issues, or personal preference

Crafted&Co. is **not responsible for lost or damaged packages** once an order has been shipped.

## **3. Incorrect or Wrong Items Sent (Our Error Only)**

If you receive an item that is **incorrect due to an error made by Crafted&Co.** (for example, the wrong product was sent), we will work with you to resolve the issue.

To report an incorrect item, you must email [craftedd.and.co@gmail.com](mailto:craftedd.and.co@gmail.com) and include:

- A **clear subject line** describing the issue
- **Proof of purchase** (order confirmation or receipt)
- Your **order details**

- **Clear photos** of the item(s) received

Once reviewed and approved, you will be required to **return the incorrect item to the provided return address**. A replacement will only be issued **after the returned item has been received and inspected**.

---

#### **4. Condition of Returned Items (Incorrect Orders Only)**

When returning an incorrect order:

- Items must be **unused, undamaged**, and in **original condition**
- Any item that has been used, altered, or damaged will **not be accepted**
- Customers must email **photo proof** of the item's condition prior to returning

Failure to meet these conditions will result in the return being refused.

---

#### **5. Errors in Personalisation Provided by the Customer**

Crafted&Co. will **not issue refunds, replacements, or returns** for:

- Spelling or grammar errors provided by the customer
- Incorrect names, dates, or wording entered at checkout
- Design choices selected incorrectly by the customer

Please double-check all personalisation fields before placing your order.

#### **6. Lost, Damaged, or Stolen Packages**

Crafted&Co. is **not responsible** for:

- Packages lost in transit
- Packages marked as delivered but not received
- Packages damaged after shipment

Once a package has been handed over to the courier, responsibility transfers to the shipping provider.

#### **7. Returned to Sender / Insufficient Address**

Packages may be returned to us due to an **insufficient or incorrect address**, including missing house numbers, apartment/unit numbers, or delivery details.

It is the customer's responsibility to ensure that a **FULL and accurate address** is entered at checkout.

Crafted&Co. is **not responsible for insufficient or incorrect addresses submitted by the consumer**.

## 8. Address Changes After Ordering

If an address error is noticed **before receiving the order confirmation email**, customers have **3 days** to request a correction by emailing [craftedd.and.co@gmail.com](mailto:craftedd.and.co@gmail.com).

- Use a **clear and urgent subject line** (e.g. "ADDRESS CORRECTION – ORDER #1234")

After this 3-day period, or once an order has entered production or been shipped, **no address changes can be made**.

Due to the popularity of our brand, we receive a high volume of emails daily. Clear subject lines help us respond more efficiently.
